4. First Aid Measures

7. Handling and Storage

Conditions for safe storage, including any incompatibilities: Store in a tightly-closed container when not in use. Store in a cool, dry, well-ventilated area away from incompatible substances. Keep away from sources of ignition. Recommended storage temperature: 2-8°C.

Personal protection

Eyes: Based on an evaluation of the eye or face hazards present, wear



chemical splash-resistant safety glasses or goggles with side protection. A face shield may be appropriate in some workplaces. Use eyewear tested and approved under appropriate government standards such as OSHA 29 CFR 1910.133 or EU EN166. Wear gloves selected based on an evaluation of the possible hazards to hands and skin, the duration of use, the physical conditions of the workplace, and the chemical resistance and physical properties of the glove material.
