### 4. First Aid Measures

---

## 7. Handling and Storage

---

Conditions for safe storage, including any incompatibilities: Store in a tightly-closed container when not in use. Store in a cool, dry, well-ventilated area away from incompatible substances. Keep away from sources of ignition. Moisture sensitive. Recommended storage temperature: 2-8°C.

### Personal protection

#### Eyes:
