4. First Aid Measures

7. Handling and Storage

Conditions for safe storage, including any incompatibilities: Store in a tightly-closed container when not in use. Store in a cool, dry, well-ventilated area away from incompatible substances. Keep away from sources of ignition. Air sensitive. Light sensitive. Moisture sensitive. Recommended storage temperature: 2-8°C.

Eyes: Based on an evaluation of the eye or face hazards present, wear
