### 4. First Aid Measures

---

## 7. Handling and Storage

Appropriate engineering controls: Avoid contact with skin, eyes, and clothing. Wash hands before breaks and immediately after handling the product. ### Personal protection

#### Eyes:

Based on an evaluation of the eye or face hazards present, wear chemical splash-resistant safety glasses or goggles with side protection. A face shield may be appropriate in some workplaces.
